Thesis Statement:

The short story "Evil Robot Monkey" by Mary Robinette Kowal uses setting, personification and symbolism to show that humans consider themselves superior to all else, and disregard the damaging impact their actions have on nature.

Explanation:

- Sly is put on display within his pen, and is made available for all visitors of the zoo to interact with him at any time.
- The constant invasion of privacy causes Sly obvious unhappiness, as he reacts by throwing his clay vase at the window in rage.
- In addition, the fact that Sly can cross the room in three strides, indicates it is very tiny, giving him very little room to roam freely.
- He is clearly confined to a space smaller than a wild animal deserves. The humans in the zoo have exploited Sly as a means to showcase their scientific breakthrough, as well as to make money by allowing visitors to view him in his pen like a circus animal.
- Regardless of Sly's obvious rage and displeasure towards his environment and the lack of respect shown to him, the humans disregard Sly's unhappiness and keep him confined in a pen. Instead the humans value only their needs above that of the nature in their care.
