Ray Bradbury was likely inspired to write "There Will Come Soft Rains" by the events of World War II and the bombing of Hiroshima. The author alludes to these events through his vivid descriptions of the remnants of the city, such as the following: "The house stood alone in a city of rubble and ashes" (Bradbury, 1). He then provides insight into the origin of such destruction, when the narrator states, "At night the ruined city gave off a radioactive glow which could be seen for miles" (Bradbury, 1). The description of the "rubble and ashes" and the "radioactive glow" here are similar to the images we often find in textbooks and documentaries depicting the aftermath of the great wars. As Bradbury himself witnessed the events of WWII and survived, he would have been familiar with such images. Much like Hiroshima's decimation at the hands of the atomic bomb during WWII, the city in Bradbury's story is similarly demolished. Bradbury's city has been left in heaps of broken "rubble" and piles of "ash" likely as a result of the initial explosion; the buildings are broken and fragmented, and organic material has been incinerated and reduced to "ash." In addition, the landscape continues to glow with the poison of radioactive waste. Such a substantial quantity of radioactivity, one that "could be seen for miles," would be vast; thus, the source must be from a large-scale nuclear event. Altogether, when the reader considers the physical destruction of the city and the radioactive waste that is left behind, it is most plausible that Bradbury is illustrating the mass destruction that

only war and nuclear weaponry can bring to the world. Thus, as the events of WWII

forever shaped our view of the world, it likely inspired many authors in the time that
